### APPLICATION FOR HIGHWAY OCCUPANCY PERMIT

#### Important directions to the applicant:

1. Submit applications to the Code Enforcement Director at the Media Municipal Center, 301 N. Jackson Street, 2nd floor government offices, **a minimum of ten (10) working days** prior to the first date upon which you would like occupy the street.
2. Highway occupancy permit fee of \$25 must be submitted with this application.
3. Permit shall be limited to seven (7) day duration.

**GENERAL CONDITIONS FOR HIGHWAY OCCUPANCY**

- Written permission must be obtained from the code enforcement officer to occupy a Borough street with dumpsters, building materials, or equipment.
- Where such permission is granted, the following criteria must be complied with:
  - 1) Objects authorized by permit to be stored or placed upon Borough streets must be protected with a sufficient number of barricades so that the obstruction is clearly identified to motorists and pedestrians.
  - 2) From 1 hour before sunset until 1 hour after sunrise these barricades will be provided with illuminated warning lights so that the obstruction is clearly identified to motorists and pedestrians
    - a) Illuminated barricades will have sufficient candlepower to readily identify the obstruction from a distance of 100 feet
  - 3) Dumpsters or stored building materials may not block the gutters. Loose materials such as sand or stone must be kept from washing down the gutters and into storm drains.
