1. Applications for review are to be submitted to the Code Enforcement Department at the Media Municipal Center, 301 N. Jackson Street, 2nd floor government offices.
2. Application must be accompanied by two (2) color copies of the proposed sign, awning or canopy.
3. When applying for a free-standing sign, a plot plan must accompany the application.
4. All signs, awnings, and canopies must be approved by the Code Enforcement Director.
5. All signs must conform to the requirements of Chapter 311, Article E-IV- Sign Regulations, of the Media Borough Code. Copies of these regulations are included with the sign application package available at the Media Municipal Center, 301 N Jackson Street.
6. Sign application/processing fee of \$100 per sign must be submitted with this application.
