ORDINANCE NO. ~~117~~3 OF 2025

AN ORDINANCE OF THE BOROUGH OF MEDIA, COUNTY OF DELAWARE, COMMONWEALTH OF PENNSYLVANIA, AMENDING CHAPTER 291 (“VEHICLES AND TRAFFIC”), ARTICLE III (“PARKING REGULATIONS”), SECTION 291-24 SUBSECTION D (“ZONES ESTABLISHED”) AND SECTION 291-28 (“DEPOSIT OF PAYMENT IN METER OR KIOSK; OVERTIME PARKING PROHIBITED; EXTENDING PARKING TIME PROHIBITED”), SUBSECTIONS (1) AND (4) TO REDUCE MAXIMUM PARKING TIME IN QUICK STOP SPACES TO 10 MINUTES AND ALLOW FOR FREE TEN-MINUTE PARKING IN ZONES 1 AND 4 WHEN USING SMARTPHONE APP

BE IT ORDAINED AND ENACTED, by the Borough Council of the Borough of Media as follows:

Section 1: Subsection (D) of Section 291-24, titled “Zones established”, shall be amended and restated in its entirety as follows (added language underlined; removed language ~~stricken~~):

- D. Zone 4: (quick stop): In parking meter zones within a distance of 75 feet from the intersection of all streets, the Council may designate the parking spaces closest to the corner on each street and on both sides of each street as a quick-stop parking space, and when the same is done, a the meter and signage shall be installed, shall be of a red color, and thereafter, Thereafter, parking shall be no longer than 15-10 minutes during the hours specified in § 291-27 of this article.

Section 2: Subsections (1) and (4) of Section 291-28, titled “Deposit of payment in meter or kiosk; overtime parking prohibited; extending parking time prohibited”, shall be amended and restated in its entirety as follows (added language underlined; removed language ~~stricken~~):

- (1) Parking Meter Zone 1. For parking meters and/or kiosks installed in short-term parking areas in the Parking Meter Zone 1 the fee shall be \$1.50 per hour, and for durations of less than one hour at the rate of \$0.25 per 10 minutes, with a three-hour parking limit. All meter and kiosk fees for Zone 1 stated herein shall be payable and enforceable between the hours of 8:00 a.m. to 8:00 p.m. on Monday through Saturday. Notwithstanding the above, the first 10 minutes of parking shall be provided free of charge when the user initiates the parking session through an authorized smartphone app.

- (4) Parking Meter Zone 4. For parking meters and/or kiosks installed in all quick stop areas in Parking Meter Zone 4, the fee shall be \$0.25 per 10 minutes, with a maximum of ~~15~~ 10 minutes. All meter and kiosk fees stated herein shall be payable and are enforceable between the hours of 8:00 a.m. to 8:00 p.m. on Monday through Saturday. Notwithstanding the above, the 10-minute maximum parking time shall be provided free of charge when the user initiates the parking session through an authorized smartphone app.

Section 3: Severability: The provisions of this Ordinance are severable, and if any sections, sentences, clauses, parts or provisions thereof shall be held illegal, invalid or unconstitutional by any Court of competent jurisdiction, such decision of the Court shall not affect or impair the remaining sections, sentences, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Borough Council that this Ordinance would have been adopted as if such illegal, invalid or unconstitutional, sections, sentences, clauses, parts or provisions had not been included therein.

Section 4: Saving Provision: Nothing in this Ordinance, as hereby amended, shall be construed to affect any suit or proceeding in any Court, and rights acquired or liability incurred, any permit issued, or any cause or causes of action existing under this Ordinance prior to the adoption of this amendment.

Section 5: Effective Date: This Ordinance shall take effect on July 1, 2025.
