ORDINANCE NO. 1162 OF 2023

AN ORDINANCE OF THE BOROUGH OF MEDIA, COUNTY OF DELAWARE, COMMONWEALTH OF PENNSYLVANIA, AMENDING (A) SECTION 291-58 OF THE BOROUGH OF MEDIA ORDINANCES (SCHEDEULE V (ONE-WAY STREETS)) TO ADD THE BLOCKS OF AMBER STREET BETWEEN N. ORANGE STREET AND N. LEMON STREET FOR PURPOSES OF MAKING AMBER STREET A ONE-WAY STREET; AND (B) SECTION 211-3(D) OF THE BOROUGH MEDIA ORDINANCES (RESIDENTIAL PARKING PROGRAM) TO ADD THE BLOCKS OF AMBER STREET BETWEEN N. ORANGE STREET AND N. LEMON STREET FOR PURPOSES OF RESTRICTING PARKING ON AMBER STREET TO RESIDENTIAL PARKING ONLY

BE IT ORDAINED AND ENACTED, by the Borough Council of the Borough of Media as follows:

Section 1: Amendment of § 291-58. Schedule V: One-Way Streets. § 291-58 of the Code of the Borough of Media, entitled "Schedule V: One-Way Streets," is hereby amended by adding the following locations:

<i>Name of Street</i>	<i>Direction Of Travel</i>	<i>Limits</i>
Amber Street	East	N. Lemon Street to N. Orange Street

Section 2: Amendment of § 211-3(D): Residential Parking Program. § 211-3 of the Code of the Borough of Media, entitled "Residential Parking Program," subsection (D), is hereby amended by adding the following location:

"Amber Street between N. Lemon Street and N. Orange Street"

Section 3: Severability: The provisions of this Ordinance are severable, and if any sections, sentences, clauses, parts or provisions thereof shall be held illegal, invalid or unconstitutional by any Court of competent jurisdiction, such decision of the Court shall not affect or impair the remaining sections, sentences, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Borough Council that this Ordinance would have been adopted as if such illegal, invalid or unconstitutional, sections, sentences, clauses, parts or provisions had not been included therein.

Section 4: Saving Provision: Nothing in this Ordinance, as hereby amended, shall be construed to affect any suit or proceeding in any Court, and rights acquired or liability incurred, any permit issued, or any cause or causes of action existing under this Ordinance prior to the adoption of this amendment.

Section 5: Immediate Effect: This Ordinance shall take effect and be in force from and after its approval of this amendment.


